### **Who Can Apply?**

- A CPM candidate who has completed all courses except for the MPSA track.
- A CPM member who has demonstrated a desire for leadership through having chaired a committee or currently chairing a committee.
- Application must be accompanied by a letter of support by the applicant’s employer or an IREM member.
