The Past Presidents’ Scholarship will be awarded to a CPM® candidate to be used for either the cost of the MPSA course to finalize the CPM® designation (all classes must be taken and only the MPSA left), or awarded to a CPM® member to attend the West Regional Leadership Conference or the Global Summit Conference, to gain leadership experience (must have demonstrated a desire for leadership through having chaired a committee or currently chairing a committee).

Scholarships Available:

- (2) Individual Scholarships to be used towards either the tuition of the MPSA Track, or attendance at the 2019 West Regional Leadership Conference (in Denver) or the 2019 Global Summit (in San Francisco).

Submission Deadline:

- Applications MUST be received by September 14, 2018.
- Award recipients will be notified by September 28, 2018.

Who Can Apply?

- A CPM® candidate who has completed all courses except for the MPSA track.
- A CPM® member who has demonstrated a desire for leadership through having chaired a committee or currently chairing a committee.
- Application must be accompanied by a letter of support by the applicant’s employer or an IREM member.
